1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. DEFINITIONS.
4	In this Act:
5	(1) Crimes.—The term "crimes" means—
6	(A) any crime related or contributing to

the illegal fishing and wildlife trade, illicit min-

1	ing, or illegal logging and land-clearing in the
2	Brazilian Amazon; and
3	(B) associated corruption, financial crimes,
4	and violent crimes (as such terms are defined
5	by the laws of Brazil).
6	(2) International financial institu-
7	TIONS.—The term "international financial institu-
8	tions" means—
9	(A) the World Bank Group;
10	(B) the Inter-American Development Bank
11	Group; and
12	(C) the International Monetary Fund.
13	(3) Relevant federal agencies.—The term
14	"relevant Federal agencies" means—
15	(A) the Department of State;

6	(a) In General.—The Secretary of State should di-
7	rect the Assistant Secretary of State for International
8	Narcotics and Law Enforcement Affairs, in coordination
9	with relevant Federal agencies and the United States mis-
10	sion in Brazil, to prioritize supporting Brazil's efforts to
11	identify and disrupt the complex and transnational crimi-
12	nal networks contributing to the destruction of commu-
13	nities and deforestation in the Brazilian Amazon by pro-
14	viding capacity building and technical assistance, includ-
15	ing—
16	(1) information sharing, training, and capacity-
17	building for Brazilian agencies, including through
18	United States Government agencies;
19	(2) collaborating on tracing funds generated
20	from crimes;
21	(3) supporting investigations of crimes that are
22	associated with deforestation, environmental deg-
23	radation, money laundering, asset laundering, or
24	corruption offenses;
