Federal Shutdown Information and Resources

I have heard from many federal employees who are either furloughed or working without pay since the shutdown began. The current situation is a true hardship on our dedicated civil servants and their families and I will continue to support legislation and actions that will bring do everything possible to fund and reopen the government.

To date, I have supported numerous bills that together would fully restore funding to agencies that have been impacted by the shutdown, as well as bills that will ensure that all federal employees and some contractors receive back-pay. I will continue to advocate for our federal workforce and seek out solutions to this crisis.

My office has compiled the following information on available resources that might be able to provide assistance to impacted individuals and their families:

FILING FOR UNEMPLOYMENT

You must file for unemployment in the jurisdiction in which your employer/employing agency is based. Therefore, even if you live in Virginia, if you work in DC, that is where you would file. This is a little trickier you work at a Virginia or Maryland office of a federal agency because you would need to determine where your employer/agency is based. Please look at your 2017 W-2 or at a current paycheck stub to check the address of the employer that is listed. Once you determine the location of your employer, you can sign up for unemployment on-line through one of the below links:
