18 Section 5545b of title 5, United States Code, as19 amended by section 3, is further amended by adding at20 the end the following:

"(f) Not later than one year after the date of enactment of the Federal Firefighters Families First Act, the
Office of Personnel Management shall prescribe regulations establishing the maximum number of regularly reoccurring hours which comprise a workweek for a firefighter

covered by this section. The maximum number of such
 hours shall not exceed an average of 60 hours per week.".

3 SEC. 5. EFFECTIVE DATE.

4 The amendments made by this Act shall apply with 5 respect to any annuity entitlement to which is based on 6 a separation from service occurring after the end of the 7 60-day period beginning on the date of the enactment of 8 this Act.
